Health projects program: In 2018, we expanded our health projects program with our neuro study. In diagnosing and treating rabbits with neurological disease, we uncovered a possible new cause of neurological disease, and did additional specialty testing and treatments. We tested rabbits with other rescues and shelters, and in homes, across the country. We presented on our research at the Exoticscon veterinary conference. The health projects program received a generous donor-designated gift in 2018, for health projects to help rabbits.

Spay/Neuter program: We held 1 low-cost spay/neuter clinic, performing 17 surgeries for the public and 2 for rabbits in our care. Scheduling changes with the surgery space we had previously been renting prevented us from doing additional spay/neuter clinic days.

Emergency Rescue and Chapter Grant program: Aided shelters/humane societies and rescues with 21 rabbit emergencies, providing financial and technical assistance to rescue over 953 rabbits.
